


## **EDITOR'S NOTE**

## LOCKDOWN DIARIES

#### Travails of a False Positive



Now it can be told. But at the time it happened, the topic was still taboo – and that was only two months ago. I'm referring to my Covid test result last Nov. 17 when the Delta variant was still dominant while Omicron had not reached our shores yet. At 11:30 that morning, our family driver dropped me off at the lobby of New World Hotel Makati for the 15th CFO of the Year (CFOY) awarding ceremony. This was the first face-to-face event open to FINEX members since the start of the pandemic.

Just ahead of me at the queue to the hotel entrance was President-elect Mike Guarin whom I congratulated. Behind me was PLDT executive Debbie Tan, and we chatted about her younger brother who was my classmate in college.

As we entered the lobby, then President Francis Lim greeted us. I was holding two of the trophies that the FINEX 50 coffee table book won during the 2021 IABC Quill Awards. I turned them over to the FINEX Secretariat at the reception table outside the New World ballroom.

An usherette directed me to a function room where CFOY attendees had to undergo swab tests before being allowed to enter the ballroom. While waiting for my turn, I talked to Toti Bengzon of Ayala Group and Mike Toledo of Metro Pacific Group, who were seated close by. On the other side of the room were some familiar faces waiting for their test results.

Then the nurse called my name and made me choose between a nasal or a saliva swab test. Out of curiosity, I selected the latter because all my previous swabs were nasal. Besides, it was less invasive and quicker to finish.

One other nurse was in charge of giving out the results, and I noticed that she was calling even those who came after me to tell them their results, which were all presumably negative since they did not have to stay behind.

Finally, when I was the only attendee left in the room, the two nurses broke the devastating news: "Sir, you tested positive." My world caved in, and I got worried about having contaminated my family and household staff, along with Mike G, Debbie, Atty Francis, Toti, Atty Mike, and the Secretariat guys whom I had just interacted with.

Yet I didn't feel any symptoms at all and was not exposed to anyone with Covid in the past 14 days!

Can I take a re-test? The male nurse asked their supervisor over the phone and the answer was a big NO. Instead, they asked for my home

By then, it was already past 12 noon and everyone was inside the ballroom except me. My first instinct was to call my wife who was also shocked at the turn of events. She said we should immediately inform the Makati City health department, which I did through a friend at

address and contact number so that somebody from their head office can send a crew to swab-test my family members.

City Hall and was told that they required a copy of the test results so I could be endorsed to a quarantine hotel. When I asked the nurses for the official test results, they said I should wait for a call from their head office to discuss the next steps. In a state of panic, I left the hotel and proceeded to the Greenbelt Chapel where a mass was about to end. I prayed in a secluded corner and avoided staying near other people for fear of contaminating them.

Suddenly my phone rang and on the line was a marketing agent of the swab test provider who got my number from the two nurses at the hotel. She said they could not produce a copy of my swab results because the test kit they used had not been cleared by the FDA and the DOH. What the ?%#&!

So I had nothing to present to the Makati health office after all. But I did not want to expose my family if indeed I had Covid. Despite my predicament, I had the presence of mind to get in touch with our "suki" swab test provider to visit my house so everyone there could be tested.

Then I remembered the quarantine hotel in Salcedo Village where my son stayed upon his return from New York two weeks prior. Luckily there was an available room when I checked the app, so instead of asking our driver to pick me up or taking a Grab, I just walked from Greenbelt to Salcedo – still being mindful not to be a virus spreader along the way by wearing double masks and keeping a distance from other pedestrians.

Upon checking in, I ordered food from the hotel coffee shop because I had not eaten since breakfast. After settling down and relieving my hunger, I requested for a swab test to be conducted. Meanwhile, I received the good news from my wife that everyone in our household had tested negative! Hallelujah!

It further bolstered my suspicion that the swab test at New World actually rendered a false positive. That night, I prayed and prayed for a negative result. True enough, when I woke up the following day, the medical report said NEGATIVE!!! This was one of those rare times when it paid to think negative.

But what a traumatic experience I wouldn't wish on anyone else. And what a difference a couple of months make: everyone now seems proud to announce on social media about having tested positive (after "Poblacion Girl" became the talk of all the New Year parties). Quo vadis, Omicron?






