LENT BEYOND NUMBERS

The season of lent expects sacrifices that finds its forms in praying, abstinence, fasting and even on almsgiving. On these self-denial efforts, we might find ourselves confined on the frequency of doing them perhaps, at times with the amount or price but, generally on what is quantifiable. Hopefully, we are not lost in the process because the real focus should be in the actual work of "making present" of the ultimate sacrifice the Lord himself offered as a concrete example for all of us to emulate.

We repeatedly hear the words taken from the Bible which goes, "For God so loved the world that he gave his only Son, so that everyone who believes in him might not perish but might have eternal life." This sums up the sacrifice we are to consider greatly and it directs us to see such sacrifice both as the object and the subject. Simply put, the one sacrificed is the one who sacrifices. Moreover, for us to appreciate it well, we can understand this more with the words of St. Paul as he explains with the Philippians who Jesus really was along with the wonderful work of salvation he has done as a sacrifice for us all, "though he was in the form of God, did not regard equality with God something to be grasped. Rather, he emptied himself, taking the form of a slave, coming in human likeness; and found human in appearance, he humbled himself, becoming obedient to death, even death on a cross". This self-emptying of Jesus is the real center of the Lenten season. This is what we are to take as a sacrifice.

There are other sacrifices of self-emptying we can consider and the most evident among all is forgiveness. Jesus clearly manifested this even when he was already crucified. He even uttered words so important for us to live by in the presence of those who brought him to the cross, "Father, forgive them, they know not what they do." Another worth considering is the "washing of the feet". This gesture which would normally not be done by masters with their servants exacts a moving away from one's presumed identity in order to be of service to all. Surely, these sacrifices are not to be taken literally since we cannot just embrace physical death or washed feet from here and there. Although, we can make forgiving as an exception.

Forgiveness is not really easy to give. But, as we all know this is more of a gift to the one who gives rather than to the one from which it is given.

It is good to be reminded though that this doesn't mean we are to give up the challenges of the pillars of Lent such as prayer, fasting and abstinence. Since these too are all articulated well in the Holy Scriptures, what we are saying is that the real focus should be placed at the center so as these pillars might not lead for an unfortunate detour.

INTRAMUROS AFTER DARK TOUR: A WALK THROUGH THE PAST

On a balmy Saturday night in November, the members and friends of the FINEX Arts and Culture Committee walked around Manila's historic walled city, the Intramuros. Established in 1571 by Miguel Lopez de Legazpi on the south bank of the Pasig River, Intramuros ("within the wall") was the centerstage of Philippine history, having been the seat of power of the Spaniards, then the Americans after the Treaty of Paris, and finally the Japanese during World War II.

For any history lover, a tour of Intramuros is a must. But doing one during nighttime is truly a one-of-a-kind experience. Our guide, Butch Pedalino, veterinarian by day, history buff at night, gave us a two and a half-hour (shortened from the original four hours) history lesson, interspersed with urban legend and commentaries, while walking around the cobbled stones of the walled city. Meeting at Plaza Roma, we walked to Fort Santiago, seeing the prison cell of our national hero Dr. Jose Rizal and even going through the dungeons where 600 decomposing bodies were discovered by American forces after their return in 1945. We returned to the Manila Cathedral for some photographs then moved to the Memorare-Manila, where we lit candles for the more than 100,000 civilians who were killed during the battle for the liberation of Manila. We then walked to the Plaza San Luis Complex where we saw the piedra china (granite from China), which dated even earlier than the Spanish colonization. We finished at the San Agustin Church, the oldest stone church in the country. The warm night lights gave the whole place a golden sheen, making everything look lovely and quite romantic.

Still, while walking around, I could not help but sigh and wish for our nation to give more attention and funding to preserving our history and heritage. Hundred-year-old artifacts are left to the elements without regard for their cultural and educational value. If only we put to heart the words of Dr. Rizal, "Ang hindi marunong lumingon sa pinanggalingan ay hindi makararating sa paroroonan," then we would realize the importance of saving our

past.
