"By 2028, 15% of decisions in organizations will be made by AI agents", shared Marie-Claude Ferland, APAC AI Strategy Leader of Ernst & Young. Today, AI has become a critical tool for driving innovation, growth, and investment for Philippine companies.

Ferland highlighted that the Philippines has taken significant steps to harness the power of Al:

- On July 3, 2024, the National Al Strategy Roadmap and Center for Al Research were officially launched.
- Fiscal and non-fiscal incentives have been introduced under the CREATE MORE Act, positioning the country as a hub for Al innovation.
- Major initiatives such as the Philippine
 Digital Infrastructure Project, the National
 Broadband Program, and the Common
 Tower Program were rolled out to
 strengthen digital infrastructure.

Additionally, **88% of Philippine business leaders** expect AI to be integrated into business processes and workflows within the next three years, further reinforcing the global shift towards an AI-driven future. Meanwhile,



Hon. Nylah Bautista, Assistant Secretary of the Department of Trade and Industry, discussed both the **challenges and opportunities** surrounding AI adoption in the country.

Challenges:

- Limited local use cases
- Lack of enterprise capacity to develop data strategies
- Emerging legal and regulatory uncertainties

Opportunities:

- Cost reduction and process efficiency
- Growth, innovation and insights
- Improved government services

Assistant Secretary Bautista emphasized that collaboration between the government, stakeholders, and the private sector, including organizations like FINEX, is the key to responsible adoption of AI.

"Together we can unlock new opportunities, foster inclusive growth, innovation, and drive digital transformation that will benefit both the Philippines and our global partners," Assistant Secretary Bautista concluded.
